The rates listed below will apply for the term of every line of service activated under the additional Terms and Conditions listed below. Subsequently published rates for wireless services purchased through MACH Networks will not be applied retroactively to any monthly recurring charges for those previously ordered, continuously active lines in good standing and in accordance with the MACH Partner Program requirements and the Underlying Service Agreement. The rates listed applicable to Service Components are subject to change from time to time as set forth in the Agreement, including, without limitation, by publication of a new pricing schedule. In such an event, as of the effective date of any new Rate Card, the new rates will replace the rates for the Service Components in any prior Rate Card for all subsequent orders. References in this Rate Card to a Service Component are not an indication of the availability of a specific Service Component. Not all services or features may be available. A MACH sales representative should be consulted for specific Service Component availability information.

1.1 MACH NO OVERAGE LTE (NOLTE)

DATA PLANS: MACH NOLTE Plans are a nationwide connectivity solution that provides a data only LTE wireless connection for use at fixed locations using LTE enabled routers. MACH NOLTE Plans offer tiered speeds, of up to 3 Mbps, 8 Mbps, 12 Mbps, 50 Mbps, and 100Mbps with no overage charges. Prices are for data plans only. **Service Terms:** A one (1) year Service agreement is required. **Eligibility:** Available only to business customers. **Eligible Devices:** Plans may only be used for a line of service using a certified and approved data-only wireless router located in a fixed location using machine-to-machine business applications needing wireless data communication between the router and the Internet or the Customer's data center. Each qualified device activated with a MACH NOLTE Plans must have a primary place of use ("PPU") within MACH's owned and operated wireless network coverage area within the continental U.S. Solution Provider may not use Service with any device other than carrier approved LTE enabled routers. MACH may place the non-complying device(s) on the appropriate plan(s). If a device not designed for the Service is used with this rate plan, MACH reserves the right to switch Solution Provider to an appropriate plan and bill Solution Provider the associated fees for such plan. **Unlimited Data:** Plans do not include roaming and are not designed to support streaming media. **Tiered Data Speeds:** Data speeds for each plan are maximum data speeds; actual speeds may be slower, particularly after a usage threshold has been met. 50Mbps and 100Mbps tier peak data speeds are not available in all MACH 4G/LTE coverage areas and requires 5G Evolution capable devices. **Data Restrictions:** After a data usage threshold on a line has been met in any given month, MACH may slow the data on that line during periods of network congestion for the remainder of that billing cycle. The thresholds are 100 GB for the 50Mbps plan, 75 GB for the 12Mbps plan, 50 GB for the 8Mbps plan and 20 GB for the 3Mbps plan. MACH NOLTE Plans are not intended for use with streaming video, or streaming audio, web hosting or public/guest Wi-Fi. **Excessive Use Policy:** MACH NOLTE Plans are intended to be used for End User Customer's official business use only. MACH Wireless Broadband routers on the cellular data network will be used to support business-critical applications and business critical data. These business-critical applications do not include primary connectivity, streaming media, or customer Wi-Fi. If the customer premise device is improperly configured or provisioned,

Reseller agrees to have the data plan changed to a 5GB or 10GB plan at MACH's discretion, and overage charges may apply. **Management Policy.** MACH requires that the router be used with a cloud-based remote management solution to manage end user traffic and ensure end user is not in violation of the use restrictions. MACH will identify users with excessive usage and will notify Solution Provider. Solution Provider will engage the End User Customer to review if the usage is in line with official business use for business-critical applications and business critical data which does not include streaming video, streaming audio, web hosting and public or guest Wi-Fi. If user is not in compliance with these terms, MACH may require Solution Provider to move that user to a Business Connect Pooled Plan. If excessive usage is within business use, Solution Provider will work to identify and implement an alternative solution, included (but not limited to) discussing efforts for Wi-Fi offload, application settings, and other network efficiency adjustments such as using a managed service to restrict usage. MACH may provide excessive usage notification during or after any billing period; Solution Provider will have the following billing period to take action upon receipt of the notification. Failure to take action could result in the line being disconnected or moved to another rate plan and loss of future access to Wireless Broadband plans. **Acceptable Use Policy.** Solution Providers agree to prohibit usage as follows: (a) operate a call-center service, telemarketing-center service, monitor service, intercom service, conference-bridge service, transcription service or other similar service; (b) make mechanized voice calls, including, but not limited to, extensive call forwarding, the use of auto-dialers, the use of fax machines for fax blasting or fax broadcasting, or the use of voice programs for voice blasting; (c) download or upload streaming content (including music and video content); or provide Wi-Fi services to end customers. **No Overage LTE for Wireless Failover.** It is the Reseller's responsibility to ensure the customer premise router, firewall, SD-WAN appliance, or other customer premise device is properly configured to limit data usage on the LTE device to Wireless Failover. If the customer premise device is improperly configured or provisioned, Solution Provider agrees to have the data plan changed to a 5GB or 10GB plan at MACH's discretion, and overage charges may apply.

MACH DYNAMIC TRAFFIC MANAGEMENT – ENTERPRISE: Feature uses quality of service ("QoS") network technology to give Customer a differentiated (i.e., enhanced versus "best effort") 4G LTE network

experience for Business Application data traffic originated on and traversing entirely over the MACH-owned domestic 4G LTE network (i.e., excluding microcells, MACH Wi-Fi service, and roaming partners' networks). The feature is included on the 50Mbps, 12Mbps and 8Mbps plans. The feature does not include preemption. **Device Requirements:** Each line must have a qualified MACH NOLTE data plan and an applicable 4G LTE/5G Evolution-compatible device provisioned with a Business Application used for transport of data to Customer's data center also provisioned with a Business Application. **Business Application:** Applications that are used for the transmission of Customer's data to and from its authorized CRU lines' 4G LTE/ 5G Evolution-enabled Equipment, including routers, (each, (c) MACH Intellectual Property. MACH, the MACH logo and all other MACH marks contained here are the trademarks of MACH Intellectual Property and/or MACH affiliated companies. The information contained herein is not an offer, commitment, representation or warranty by MACH and is subject to change. Carrier logos are a trademark of the carriers and or its affiliated companies. a "Business Application".
